2) Organization Review Comments

Russ Farmer gave an overview of the organizational review process.

He explained the scope of the review is very broad and will cover areas such as people management, SOGs, organizational design, capacity, service standards, staffing as well as other concerns that arise during the review.

The review is intended to be as inclusive as possible so they will interview board members, administration, and the district fire chiefs and send a survey to the volunteer members. If members are not comfortable completing the survey, they will be able to provide their comments directly to the organizational review team.

He noted it is critical that the board share results of the process with all members.

3) 5 Year Apparatus Plan

REM Weiss provided an overview of the 5 year apparatus plan and then opened the floor for comments. Comments arising from the discussion included the following

- Station 1 is responsible for the Blackfoot Grazing area and the Ministik Bird Sanctuary. Quads are more suitable to accessing these areas that Side X Side units. Station 1 is gathering information regarding the safety of quads.
- Unit 14 Utility Truck replacement consider replacing with a cab and chassis unit with cabinets to safely transport personal protective equipment helmets are to be transported in cabinets.
- The senior's villa in Tofield is a 3 storey building consider a ladder truck for 3rd floor rescue
- Station 4 agrees moving a tanker to Kinsella is a good idea however, the requirement for a class 3 license plus airbrakes creates a challenge.
- Station 3 only has 3 units, therefore the configuration of its rescue unit may need to be a bit different than the other stations for example a crew cab rather than a 2 door unit.
- Station 3 may need an expansion in the future, if so, give consider cutting the lot down rather than building it up for an addition.
- As Station 3 does not have a pick up, members use their personal vehicles for hauling hose.
- Station 2 members need to get class 3 plus airbrakes.
- Station 1 is a registered training location so members who need to upgrade their licenses can to it there.
- BESC needs to look at its other capital asset requirements building and equipment
- SCBA meets old standards it needs to be upgraded overtime costs are significant. Upgrades to SCBA will require compressors and fill stations upgrades.
